This is a summary of drug and health services covered by PruittHealth Premier (HMO I-SNP) January 1, 2023 - December 31, 2023.

PruittHealth Premier (HMO I-SNP) is a Medicare Advantage HMO Plan (HMO stands for Health Maintenance Organization) with a Medicare contract. Enrollment in the Plan depends on contract renewal.

The benefit information provided is a summary of what we cover and what you pay. It does not list every service that we cover or list every limitation or exclusion. - be entitled to Medicare Part A,
- -- and -- be enrolled in Medicare Part B,
- -- and -- live in our service area,

-- and -- reside in one of our participating nursing facilities for greater than 90 days or live in a
community setting (including in an assisted living or independent living community) and meet
the institutional level of care. The plan's *Provider Directory* has a list of participating nursing
facilities. You can access this list on our website PruittHealthPremier.com or call Member
Services and ask us to send you a list.
